He worked as vice-chairman of OECD's Employment and Social Affairs Committee in 1996, In 2002 he was advisor to the minister of economy. He worked at SPO-Ministry of development between 2007-2011. Since 2011 he works as economy advisor. His research and publication areas mainly include macroeconomic and social policies, the knowledge economy, development, corporate governance.

O.Cevdet AkŐay completed his high school education at Robert College, received his B.A. in economics from BoŐaziŐi University, and his M.Phil. and Ph.D. from Graduate School and University Center at City University of New York. He served at BoŐaziŐi University as Asst. Prof. and as Assoc. Prof. between 1992-2001, and was full-time faculty member at KoŐ University between 2001-2009. He worked as Chief Economist at KoŐ Financial Services and Yapi Kredi until May 2018. He currently functions as a freelance economist providing consultancy mostly for foreign banks and their clients regarding their Turkey portfolios as well as for some state institutions, the Ministry of Finance and Treasury most currently. His research and publication areas mainly include exchange rate determination, debt dynamics, and disinflation with specific emphasis on the Turkish experience in these fields.
